CONSORTIUM AGREEMENT FOR MARINNONET PILOT PROJECTS

The work plan of the Atlantic Area project MARINNONET includes the realisation of pilot projects that must be implemented according to the work plan included in the MARINNONET Subsidy Contract and application form (PAF), and in compliance with the rules of the Atlantic Area programme. The MARINNONET pilot projects are R&D&I activities corresponding to feasibility studies, exploitation or demonstration projects in the blue biotechnology sector with a maximum duration of 12 months. Pilot projects are aligned with the regional challenges identified in the Joint Action Plan of MARINNONET (https://marinnonet.eu/) and must be carried out by at least two research and development partners of the MARINNONNET consortium (one as Principal Investigator, the other as Secondary Investigator) placed in two different Atlantic regions. Additionally, projects must have an associated External Innovator, which may be subcontracted if necessary. Only members of the organisations listed in the Pilot Projects Call 1 Guidelines may be Principal Investigators of the pilot projects.. The Principal Investigator of each pilot project, and the organisation of which they are members, will be responsible to ensure compliance with the Atlantic Area financial rules, the terms of the MARINNONET PAF and Agreements (Subsidy Contract and Partnership Agreement), in the implementation of the pilot project. Specifically, they will ensure that all costs incurred in each pilot project are covered, and that only costs related to consumables and subcontracting are incurred.

Intellectual property is protected by law through, for example, patents, copyrights, industrial designs, and trademarks.

All outputs and results produced in the framework of the MARINNONET project (including those of the pilot projects) are of public interest and publicly available. They must be accessible and available to the public, generally in a usable format.
